In pursuance of the Memo No: HF/O/MS/W-03/13/PART-II/Part file/1165 dated 16.12.2014, this is to notify that District RSBY Cell (Swasthya Sathi Cell) will engage 01(one) District Coordinator-IT on contract basis. Applications will be received **online from 10/09/22 to 29.09.2022 up to 24:00 hours**. No offline application will be entertained/considered for the recruitment.

Submission of application does not guarantee acceptance of candidature of any candidate for the post. Incomplete applications shall be summarily rejected.

Method of selection:

Selection of candidates will be made through the following stages:

(A) **Written Examination:** A written examination will be held for the eligible candidates through "Multiple Choice Question" type examination of **75 (seventy five) Marks**.

(B) **Top 50(fifty)** candidates will be called for **computer test** on the basis of marks obtained in the written test followed by **interview**.

Computer Test: 20 (twenty) Marks

Interview: 05 (five) Marks

Final selection will be made on the basis of the total marks obtained by the candidates in the Written Examination, Computer Test and Interview.

Admit Cards for the written examination for eligible candidates will be available for download from the website s24pgs.gov.in. No admit card will be dispatched through post.

Period of Engagement:-

- The initial engagement for a person for the above post would be for a period of 1(one) year. Thereafter, the engagement may be renewed as per the satisfactory performance of the incumbent concerned.
- The appointment to the above post would be on full time basis and any would not be permitted to take up any other assignment during that period.
- Contract for engagement may be terminated by giving one month notice from either side (employer or employee).

Age Limit:-

Age should not be more than 40 years as on 01.01.2023. However the upper age limit is relaxable for the candidate belonging to categories of Schedule Cast, Schedule Tribe and Other Backward classes as per existing Government order.
